Case Study: Advocacy

The Live Export ban of 2011 rocked the red meat industry and halted export activities overnight. Blue Sky Agribusiness was commissioned by the Australian Goat Industry to manage return to trade and negotiate new systems with government. The approach was to form part of an Industry-Government working group on the issue. Blue Sky Ag was able to ensure that the goat industry had a voice at the table and its issues were addressed accordingly.



Case Study: Compliance

Federal Government instigating the Exporter Supply Chain Assurance Scheme (ESCAS) to ensure that Australian livestock exported from Australia were managed within an ethical supply chain. Blue Sky Agribusiness was commissioned to undertake reviews and implement improvements throughout South East Asia, including training staff. The results have been new systems and processes in the supply chain of these markets that exceed the Government's ESCAS standard.



Case Study: Supply Chain Improvement

Saleyards throughout the last 25 years have been targeted, within meat quality research, as marketing systems that have a major impact on product and eating quality within the beef industry. A project undertaken with Regional Infrastructure Pty Ltd (RIPL) aimed to provide an understanding of the way RIPL could differentiate its service, through understanding of cattle marketing impacts on cattle welfare

and eating quality. This included investigating interventions that are commonly used to either manage impacts on product quality or in fact improve product quality, review normal saleyard infrastructure and practice against the companies systems and processes and finally recommend programs for further in-depth research to underpin the definitive differentiation.
